RE: Nominations for the election of three (2) CIAA Directors

The Cook Inlet Aquaculture Association (CIAA) Board of Directors meets one Saturday every other month between the months of September and May. An annual meeting is held in February. Of the 28 Director's seats, five (5) Inlet Wide Commercial Fishermen Representatives are nominated and elected "at-large" by all permit holders. The terms of two (2) at-large seats expire at the 2023 annual meeting on Saturday, February 18, 2023. Newly-elected Directors will begin a 3-year term at the same meeting and will serve through February 2026. CIAA is seeking nominations for the at-large Director's seats that expire February 18, 2023. Nominations are made by petition. All Cook Inlet (Area H) Limited Entry Salmon Permit Holders are eligible to serve as an at-large Director.

NOMINATION PROCEDURE:

1. Each candidate for at-large Director shall list on the nominating petition a person who will serve as an alternate Director. The candidate and the alternate shall each possess a valid Cook Inlet (Area H) Limited Entry Salmon Permit.
2. The Director and alternate candidates must sign the petition.
3. The nominating petition must also be signed by at least 20 holders of Cook Inlet (Area H) Limited Entry Salmon Permits. The CIAA staff will verify these signatures.
4. Each candidate for at large director shall also submit a Candidate Application.
5. A valid nominating petition must be either postmarked by Wednesday, November 16, 2022 or hand delivered to the CIAA office by 5 p.m., Friday, November 18, 2022.

ELECTION PROCEDURE:

In the event the number of valid nominating petitions received is less than or exactly matches the number of at-large seats to become vacant, the election process will end.

In the event there are a greater number of valid nominating petitions than the number of at-large seats vacant, a ballot of properly-nominated candidates and a return envelope will be mailed to you on November 28, 2022. To be counted, ballots must be postmarked by Friday, January 13, 2023 or hand delivered to the CIAA office by 5 p.m., Monday, January 16, 2023.

**BOARD OF DIRECTORS ELECTION OF JANUARY, 2023
NOMINATING PETITION**

Each candidate and alternate shall be a Cook Inlet (Area H) Limited Entry Salmon Permit Holder.

Note to Candidate: In order for a petition to be valid, you must have a person who will serve in your absence as an alternate. That person must be listed on and must sign this petition. Signatures are invalid unless accompanied by a Cook Inlet Limited Entry Salmon Permit Number owned by the signee.
